Once you earn the CCIM designation, you do not need to reapply for the designation year after year. However, you must renew your CCIM Institute membership every year.

Q: WHAT ARE THE DIFFERENT LEVELS OF MEMBERSHIP AVAILABLE AT CCIM?

Institute Members, also called candidates, pursue the CCIM designation through one of six types of membership:

INSTITUTE MEMBERSHIP

 Institute candidacy is the most common membership for U.S.-based professionals whose goal is to become a CCIM.

CANADA

 Canadian candidacy is for professionals who live in Canada.

INTERNATIONAL

 International candidacy is for professionals who live outside the U.S. or Canada.

U.S. GOVERNMENT DISCOUNT

 U.S. government employees or military members can join CCIM at a reduced Institute candidacy rate.

UNIVERSITY FAST TRACK

 Graduates of real estate master's degree programs from approved institutions qualify for this membership program.

INDUSTRY FAST TRACK

 Commercial real estate professionals who have earned other industry designations may qualify for this accelerated program.
